This affidavit-declaration of life is given to all in order to;

- i) establish, signify, proclaim, and verify the status of this living being, and
- ii) to eliminate/deny any and all presumptions by any and all fictitious, corporate or private entities, and
- iii) to rebut any and all alleged claimed jurisdiction of any and all fictitious, corporate or private entities, over the deponent, those entities being without standing upon the land.

We say on oath;

1. We are a vibrational energy.
2. We are a vibrational awareness.
3. We are a cosmic consciousness, also referred to as a 'soul'.
4. We, being 'eternal', exist in multiple dimensions simultaneously, and inside and outside of 'time' as it is known in this 3rd dimensional realm.
5. In all dimensions we have no 'name', nor need for a 'name'.
6. We are an aspect/creation of the ALL That Is, the Supreme Consciousness, also known as the Collective Consciousness, Allah, Yahweh, Source, and/or Lord God Almighty, hereafter referred to as 'The Creator'.
7. The Creator created the universe and all aspects of it..
8. Our 'soul' was not born, it is, and has been, ever since The Creator created it.
9. Our 'soul' exists in the universe as an integral part of the universe.
10. Our 'soul' exists as, and shall remain solely as, a creation of The Creator.
11. Our 'soul' is like a drop in and of the ocean; that ocean known as The Creator.
12. The Creator created all 'matter' including, but not limited to: this planet, known as Earth; created the land, created the oceans, rivers and lakes, created the air, created all living beings and life on this planet.

13. The Creator is the supreme and only authority over this planet and all things such as matter comprising it, and all living beings living on it.
14. Our 'soul' has had many incarnations in this earthy realm.
15. Our 'soul' made a choice to incarnate into a human form, with the mother being **Betsy Lou**, born of both the family **Jones** and the family **Hall**, with the father being **Thomas John**, born of both the family **Williams** and the family **Carter** hereafter called 'the parents', both of which have physical standing upon the land.
16. Our 'soul' rebuts all presumed consent, tacit consent, and assumed compliance with all lesser authorities that are Earth based and merely human, as is our right under our personal agreement with The Creator, the maker of all universes and realities, and choose to stay under the authority of the Creator only, with no other authorities standing between.
17. Our 'soul's' unique agreement with The Creator is final, and supersedes every other agreement or authority, convention, statute, or regulation that is either Earth-based, or off-world-based, especially if it seeks to enslave our being, or limit our freedom in any way without first gaining our conscious, fully aware, and fully informed (nothing hidden) consent.
18. The use of, and/or association with, any and all previous contracts or perceived consent by our 'soul' related to any and all previous and/or alternate incarnations of our 'soul' - enacted through any form of tacit or assumed consent by another person, entity, or being, - are completely denied, voided, null, forbidden and banned in this incarnation unless a current contract or treaty has been negotiated freely and transparently with us face to face.
19. The living foetus into which we incarnated was born as a living being on the date known as the **twenty-sixth** day of the month of **June** in the year of the Lord God Almighty, **One-thousand-nine-hundred-eighty-two** on the land known as **Kew**.
20. The physical living being in which we are now incarnated is thus most directly born of both the family **Hall** and the family **Smith**.
21. The parents of the living being born of **Betsy Lou**, gave the living being the appellation '**Mary Jane**'.
22. The appellation of the live born being, as given above (19), is based upon the appellation given to the live born child by the living parent into the family or the clan known in this case as the family of **Smith**. This live born being is not associated in any way with the statutory created fiction or estates with the name **MARY JANE SMITH**.
23. The living being, '**Mary Jane**', of the family **Smith**, is a creation of The Creator.
24. The living being, '**Mary Jane**', of the family **Smith**, is not a creature, monster, animal, instrument, surety, fiction, chattel, slave, servant, subject, citizen, serf, vassal, or member of a colony, or any other similar representative of fealty or subservience.

26. The living being, 'Mary Jane', of the family Smith, is also known as 'Apollo', an appellation with which the soul making this affidavit chooses to also be identified as whilst in this realm and in this living being.
27. The 'soul', 'Apollo', plays out this incarnation through the living being, and as the living being, 'Mary Jane', of the family Smith, solely with and under the authority and blessing of The Creator.
28. The living being, 'Mary Jane', of the family Smith, is the vehicle for the 'soul', 'Apollo', to observe, operate, interact and interface within, and obtain knowledge from, these dimensional domains, both physical and non physical, living and non-living dimensions of the past, present and future, and cannot be, and is denied to be, claimed by any fiction, government, religion, corporation, species, and/or other entity.
29. The 'soul'. 'Apollo', in our own universal sovereignty, and through the living being 'Mary Jane', of the family Smith, are 'Sui Juris'; possessing our full universal free will and social and civil rights as determined by The Creator.
30. The 'soul', 'Apollo', in our own sovereignty, and through the living being 'Mary Jane', of the family Smith, being not under any legal disability to act for ourselves, nor under the power of another, nor under guardianship, nor having any earthbound authority standing between our living being and The Creator, unless designated in writing and signed by our conscious and fully informed consent, have the full capacity to manage our own affairs.
31. The 'soul', 'Apollo', and the living being we are incarnated into, 'Mary Jane', of the family Smith, renounce, rebut, disassociate and reject in its entirety the *Corpus Juris Civilis* (as issued by order of Emperor Justinian I from the years known as 529 to 534 AD), and any and all instruments subsequently and consequently constructed from it.

i) when ‘**Mary Jane**’, of the family **Smith**, was born,

ii) where ‘**Mary Jane**’, of the family **Smith**, was born,

iii) the gender of ‘**Mary Jane**’, of the family **Smith**, at the moment of it being born, nor

iv) the names given to the living being at the moment of it being born.
